Promotion Details

Promotion Start Date: Sunday 5th July

Prize Draw Dates – Every Sunday

Ticket Spit Times: 11:30am – 5:30pm

Draw Times: from 5:30pm

Entry Barrel Closes: 5:30pm

Draw Location: St Marys Rugby League Club, Sapphire Lounge

Total Value of Prize(s): \$500 each week

Members that spend \$30 or more in a food, beverage (excluding bottle shop) or raffle transaction and have their membership card added to the sale members will receive one entry into the promotion.

The tickets will print from 11:30am – 5:30pm only from the POS at all food and beverage locations (excluding the bottle shop) and the raffle POS.

The tickets need to be placed into the barrel located in the Sapphire Lounge before the draw time of 5:30pm each Sunday

HOW TO ENTER

Members must spend \$30 or more in a food, beverage (excluding bottle shop) or raffle transaction and swipe their current St Marys Rugby League Club Members card to receive one entry into the draw. Members must do so between 11:30am – 5:30pm each Sunday.

Entry tickets are issued automatically from the printers attached to the till.

Tickets will be issued based on ONE per transaction. Members can enter more than once.

Ticket is only valid for the same day draw.

Members place their entry ticket in the barrel located in the Sapphire Lounge for their chance to win.

Winners will be announced over the PA systems.

The member must be present at the time of the draw and must present themselves to the promotional host in the Sapphire Lounge within 4 minutes to claim their prize. If they do not present themselves to the host within 4 minutes a redraw will take place.

Tickets will be drawn from the barrel located in the Sapphire Lounge.

General

1. The Sunday Members Cash Giveaway is for members of St Marys Rugby League Club that meet the above 'How to Enter' criteria.

3. The promotion is open to St Marys Rugby League Club members who have placed their ticket into the appropriate entry barrel on the appropriate day.
4. Tickets will be considered null and void if placed into the incorrect entry barrel.
5. Any tickets in the promotion entry barrel other than the 'Sunday Cash Giveaway' will be considered null and void but their drawing will be recorded to ensure transparency.
6. Members must be aged 18 years or over.
8. St Marys Rugby League Club Board of Directors, Management, Staff who have been associated with the club for any time since the commencement of the promotion, are not eligible to claim any prizes on offer. Guests of members and visitors are also not eligible to enter this promotion.
