If Winner Not Present - Major Prize \$4,500 Helloworld Travel Voucher.

If Winner Present – Major Prize \$4,500 Helloworld Travel Voucher, \$500 Spending Money (Cash)

Minor Prize: 4 x Byron Bay Eskys with a case of Byron Bay Beer valued at \$400 each

**Total Prize Value if winner not present = \$6,100**

**Total Prize Value if winner is present = \$6,600**

**Number of prizes to be won: 5**

#### ENTRY:

Upon purchasing a bottle (1 ticket) or bucket of 4 Byron Bay (4 tickets) between the promotion dates and a members card is swiped in the transaction the member will receive one entry ticket per bottle or 4 entry tickets for a bucket into the prize draw.

The tickets need to be placed into the barrel located at Saints Sports Lounge before the draw time of 3:00pm during the promotion.

## HOW TO ENTER:

Members must purchase a bottle of Byron Bay beer or a bucket of Byron Bay (4) between the promotion dates and have their members card added to the sale in order to receive one entry ticket per bottle or four tickets per bucket.

The member must place their entry ticket into the barrel located at Saints Sports Lounge before the draw time of 3pm on Tuesday 26<sup>th</sup> January 2021.

Entry tickets are issued automatically from the printers attached to the point of sale.

There will be five winners drawn and their names will be announced over the PA systems. The member does not have to be present at the time of the draw to claim the prize. However, for the winner of the major prize to claim their \$500 spending money, they must be present at the time of the draw and present themselves to the promotional host within 4 minutes to claim this bonus prize (\$500 spending money).

## General

1. The **“Win a Trip to Byron Bay”** Giveaway is for members of St Marys Rugby League Club that meet the above ‘How to Enter’ criteria.

4. Tickets will be considered null and void if placed into the incorrect entry barrel.
5. Any tickets in the promotion entry barrel other than the **“Win a Trip to Byron Bay”** will be considered null and void but their drawing will be recorded to ensure transparency.
6. Members must be aged 18 years or over.
8. St Marys Rugby League Club Board of Directors, Management, Staff who have been associated with the club for any time since the commencement of the promotion, are not eligible to claim any prizes on offer. Guests of members and visitors are also not eligible to enter this promotion.
